

## **CLERGY VOICE**

Dear Friends.

There is an amazing glow around Jerusalem during the season of Chanukah. It is my favorite time to wander the Jewish quarter of the Old City and watch each Chanukiah grow with light each night. Our whole family often travels on the sixth or seventh night to see that stunning display of oil-lit Chanukah menorahs nestled in the Jerusalem stones. It is a tradition for some families to have a Chanukiah for each child they have in their family - you can only imagine the beauty of these lights! Usually we stop on our way to the Old City to buy an Aroma coffee or hot chocolate and one of the famous Roladin sufganiyot, gourmet jelly donuts stuffed with butter cream mocha, pistachio, vanilla, and dulce de leche fillings. On these cool winter evenings it is 50 degrees Fahrenheit, and we are bundled up in our winter coats. This is Jerusalem in December!

In my neighborhood, Old Katamon, we see each home lit up with the shimmering and warm glow of the oil burning lamps. Each night, my neighbor invites us to join him in lighting a Chanukiah that he sets in the entryway of our building. He lights the candles as soon as it is dark, following the mitzvah to light the candles when there are three stars in the sky.

Today I sit looking out to a cold, wintry November sky in Minneapolis.

While there are many great donut options in this area of the world, I have yet to see a display of oil lamps for Chanukah (with the exception of our beautiful Temple Israel gift shop).

Just after Halloween, my three boys screamed with delight at the sight of nutcrackers, Christmas lights on frosted trees, candy canes, and reindeer at our nearby mall. Noam said, "Mom, this year we can have a Christmas tree like all of the American people!" Of course, I quickly exclaimed

that while we can celebrate the Christmas holiday with our non-Jewish family, we will not be putting up a Christmas tree in our home. Noam was a little sad but perked up when my husband told him

that he bought a huge electric Chanukiah for us to display in our window here! This is part of the mitzvah: to light a Chanukiah in a window so that everyone can see and witness the miracle of Chanukah.

I must confess that living in Jerusalem I had missed seeing the ubiquitous Christmas trees and Santas on every corner everywhere outside of Israel. But I have grown so fond of seeing the lights of the Chanukah menorahs all through the streets of Israel during December, or Kislev, that I find myself missing them most. It is the light they give that I find so significant this time of year. The evenings are dark by 4:30 p.m. and I seek lights twinkling and cozy hot chocolate moments with family and friends, the light and glow of a fireplace as snow flurries dance in the sky... In this darkened world, let us all spread the light and keep shining our Chanukah menorahs from our windows and from our hearts. It is the mythological miracle that lasted so long ago that we carry inside of us. Let the miracles of hope march on! Let's all exclaim, "Next year...Chanukah in Israel."

I will welcome you with light!



Chanukah, meaning "dedication" in Hebrew, refers to the joyous eight-day celebration during which Jews commemorate the victory of the Maccabees over the armies of Syria in 165 B.C.E. and the subsequent liberation and rededication of the Temple in Jerusalem. The modern home celebration of Chanukah centers around the lighting of the chanukiah, a special menorah for Chanukah; foods prepared in oil including latkes (potato pancakes) and sufganiyot (jelly doughnuts); and special songs and games.

## TEMPLE ISRAEL RESPONDS...

#### WHEN THE COMMUNITY IS IN NEED

The morning of October 27, 2018 began like any other. Members of our community gathered as countless other congregations did – to study Torah, to find community, and to celebrate Shabbat. By the time the morning service had ended, news of the horrific attack on Tree of Life – Or L'Simcha Congregation in Pittsburgh had reached our community.

It was immediately clear to Rabbi Zimmerman that our congregation, the entire Jewish community, and our friends and neighbors throughout the city would need an opportunity to respond to the feelings of grief, fear, anger, and sadness that the shooting had elicited. Our Jewish tradition teaches us that we must respond swiftly in the face of tragedy. Just hours after the attack, Rabbi Zimmerman and our clergy team were already planning a community-wide service that would honor the memory

of those who were killed, provide an opportunity to mourn, and bring people of all traditions together in support of our Jewish community, and against anti-Semitism and intolerance.

On Sunday—just a day after the attack—nearly 2,000 people joined us here at Temple Israel, some Jewish; many not. Sunday was a time to stand up with great courage, and without fear, to meet the needs of our congregation and of the community around us. Temple Israel has endured for 140 years because of our wisdom, because of our tradition, and because of you. It is only through your support that we can be here to respond quickly and ably to the needs of our individual members, our families, and our city. ## MY TEMPLE STORY

## THE MIDDLEBROOKS: Closeness through Change

Twenty years ago, the odds that Genna and TJay Middlebrook would be members at Temple Israel - the odds that they would even get together - weren't good.

Though Genna has always known Temple Israel, she wasn't always sure how Temple might fit into her life. She grew up here, attending with her mother, Gail Posner. Gail passed away when Genna was just thirteen, and Genna's grief caused her to drift from her Temple family after her bat mitzvah. "It took me a while to come back..." she trails off, teary with the memory.

While Genna grew up in the Jewish faith and searched for her own truths as a young adult, TJay grew up with an entirely different perspective. "I was raised and taught to view Jews in a negative way," he said. "Growing

up, I was presented with the idea that Jews were racist in that they [deemed themselves] superior to others." In high school, he says, "I was mean to Jewish people."

This all changed when TJay attended the University of Minnesota and met Genna in 2012. Daughter Izzy, 8, loves telling the story:

"So, they were at a concert, and my mom went to my dad and she asked him, 'What's your major?'"

"No name!" TJay laughs - apparently what he studied was more important.

Genna: "I was so nervous!"

The two clicked immediately, staying up well into the night engaged in deep conversation together those first few months.



As their bond grew, Jenna was reconnecting with Temple Israel, after she enrolled Izzy in Temple's Early Childhood Center. Genna felt comfortable back with her Temple family, but was unsure how TJay would feel. "He had a very different experience with religion. I didn't know if I should invite him to join, [or if it was enough to say] 'you don't have to be Jewish, you can just be here'. I knew as a person of color, it might be different. I wanted him to feel welcome and safe."

TJay was open, but was on the defense when it came to any religion. After some time, he let his guard down. At Temple, he says, "You feel at peace and feel [like you can be] yourself," something especially valuable to him as a person of color. "I see the measures Temple takes to make people of color feel welcomed.

I've been to other temples, and [race is] rarely talked about."

TJay and Genna began their life together in 2014, when they got married exactly two years after they first met. TJay legally adopted Genna's daughter Izzy in 2016, and the three welcomed Maizy in 2017. Today, the family considers Temple a second home and fosters a great love of, and pride in, Judaism. Izzy goes to Camp TEKO every summer (she's usually ready to leave the house two hours early); Maizy goes to ECC three days a week (the family will likely have her attend five days a week next year because she loves her time there). The family goes to Tot Shabbat together, and Izzy is eager to begin her bat mitzvah training.

Twenty years ago, with Genna's relationship with Temple tenuous at best, and with TJay's previously negative views on religion in general and Jews in particular, it was extremely unlikely the two would become a family and forge such a strong connection with Temple. It's clear that Genna and TJay are grateful for each other, their family, and their Temple community.

Recently, TJay ran into a former high school teacher who was shocked he was married to a Jewish woman. While TJay credits Genna for showing a side of the Jewish religion he "needed to see," he also acknowledges that much of the shift he made was internal: "It just shows that people can change."



## WOMEN'S TRIP TO ISRAEL



Dear Friends.

Returning home to Minneapolis after our first women's trip to Israel has given me time and distance to reflect on our glorious ten days traveling to Galilee, to Jerusalem, and to Tel Aviv. The vision of the trip was to hear diverse women's voices. A slice of just one day reflects the deep listening we shared to understand the complex issues women face in the Middle East.

On October 11, we began our day hearing from a Palestinian Muslim woman, Riman Barakat, from East Jerusalem. We then traveled with her to Bethlehem, where we met a Palestinian Christian woman who started a business employing women from Bethlehem to support their families. We continued on to Efrat. There, we met Aviva Zahavi-Asa, who spoke about her life as a modern Orthodox woman and how her community is supportive of ordaining female rabbis. Returning to Jerusalem, we heard from Women Wage Peace, which promotes a bilaterally acceptable political agreement to end the Israeli-Palestinian conflict. This is just part of one day of our journey, so you can imagine the multiple points of view we heard throughout our mission.

With each person we met, the assumptions and biases that we arrived with were blown apart to demand that we both see the complexities of the region but still remain inspired and hopeful about the future. It was a magical trip, and I thank all the women who signed up and believed in this vision.

It was a very moving experience to pray and sing alongside women who were trying in such an ugly way to drown out our song. I loved the trip. It was such a unique way to see Israel. To hear so many different perspectives of the country. There are many more sides than the two we regularly hear to create peace. Some perspectives I didn't understand before. I learned there will be no easy way to create peace in the Middle East, but everyone will need some sort of compromise. One of my highlights was the Donna Garcia Museum. It was an unknown story about a woman during the Spanish Inquisition who saved so many lives and kept Judaism alive for them. 
## RECHA LEWIN SCHOLAR 2018

Each year, Temple Israel selects teens and young adults to receive the Recha Lewin Scholarship, which provides funds for travel to the former Pale of Settlement – present-day Latvia, Lithuania, Belarus, Ukraine, Moldova, and Poland. The most recent recipient of the scholarship is Sarah Rothman.

Sarah, currently a junior at Hopkins High School, is the daughter of Devora & Barry Rothman and brother of Jacob, 14. She spent a month abroad this past summer, traveling to Poland, Budapest, Prague, and Israel. She visited different synagogues, Budapest thermal baths, and historical sites. While many of her friends on the youth trip chose to visit places like Italy or France before Israel, Sarah is glad she visited these sites for their history. At the same time, "It was very difficult. I didn't expect any of what I saw," she said of her visits to concentration camps and other Holocaust sites.

Though she had learned about the Holocaust in school, she says, "Going to the concentration camp brings you to another world. This happened to us – my people." Through the Recha Lewin Scholarship, Sarah built upon her understanding of Judaism. "I have more respect for my religion after this trip."


