Dear Friends,

How do we help our teens experience the Jewish history of Minnesota? Our 9th grade class recently found a way to bring history alive, beginning with their own family stories in Minneapolis and traveling to the Iron Range.

The context for this journey began much earlier. We found that, with all of the demands on our high school students, asking them to go away on the 9th grade retreat program became overwhelming rather than fun and productive. This year, we are experimenting with a different structure. The 9th grade class meets twice a month on Sunday afternoons. The theme is: Jewish Minnesota. We are asking questions like: What brought Jews to this part of the country? What did they do here? How were they involved in different facets of society?

Our first stop in answering these questions was to look at the history of our own families and that of our synagogue. Students and parents together created family trees and shared their family stories. Then we heard from Temple's very own (volunteer) historian, congregant Marilyn Chiat, about the history of our congregation and our community. We learned how Temple came to be here, on Hennepin Avenue in our beautiful building. Our next stop was Virginia, Minnesota. There we learned about the small Jewish

community that settled on the Iron Range at the turn of the last century. We were lucky to hear first hand from Temple congregant Charlie Ostrov about his experience growing up Jewish in a small town. The students were enlightened by his stories and by the small synagogue of B'nai Abraham.

B'nai Abraham was the last active synagogue on the Iron Range. Built in 1910, it closed its doors in 1990. It was going to be demolished when a not-for-profit organization, The Friends of B'nai Abraham, acquired the building and set about repairing it. Temple members have been actively involved in this effort. Now the synagogue is a museum and cultural center that teaches about Judaism and the community that once filled the building.

It was moving to see the 9th grade class lead services in this old synagogue. It is not often used for this purpose, and the room filled with music, prayer, a sense of community and shared history.

I am excited to continue to explore the rich history and current endeavors of the Minnesota Jewish community with our wonderful 9th grade students!

## · Mitzvah of ma'akhil re'evim · Feeding the Hungry ·

Temple Israel celebrated the rare convergence of Thanksgiving and Chanukah in style. Young and old, friends and family gathered together, not once but twice, to perform the mitzvah of ma'akhil re'evim, feeding the hungry – and what fun we had!

On Sunday, November 3, some 250 Temple Israel students, parents, grandparents and friends packaged a record 33,912 dried nutritionally balanced meals for hungry families. Hospitals, schools and refugee centers in Afghanistan are distributing the meals to impoverished families through Food For Kidz and its overseas affiliate.

Temple's 7th and 8th grade classes oversaw the project, led by congregant volunteers Steve Levine, Michael Sigel, Ignacio Garrigos and Dean Goldberg, along with Joey Sigel. Fremajane Wolfson generously sponsored the project in celebration of her 70th birthday, making it

"Thank you for the best birthday present I have ever received," Wolfson said. "You packaged so many meals and accomplished so much. What a mitzvah! We are so blessed to be able to participate in the generous act of tikkun olam."

After HaKol went to press, several hundred more Temple volunteers prepared and delivered hot meals to hungry Minneapolis families on Thanksgiving Day, which fell on the first full day of Chanukah. Organized by TIPTY, Temple's youth group, and generously underwritten by Anne & Allen Wolf in memory of their son, the 21st annual Stephan Larson Wolf Memorial Thanksgiving Day Meals-On-Wheels Program got its own special name this year - Templegivukah-ThanksTIPTYah!

The Torah teaches "Eim Ayn Kemach, Ayn Torah." If we don't have basic sustenance, there can be no Torah. In 5774, let it be said that Temple Israel gave thanks with sustenance and celebrated Chanukah with justice.


#### **Meet Your Temple Israel Officers**




whenever you need it." Roberta is the CEO/President of Greater Good Kids, which operates Creative Kidstuff and Sensational Beginnings.



## **Temple Israel Finances**

## **Frequently Asked Questions**

#### **→ Does Temple Israel have a balanced budget?**

Yes. Fiscal responsibility is a top priority for the Board of Directors. In fact, for the first time in Temple's history, a financial audit is conducted annually by an outside accounting firm. Temple's budget has been balanced for many years, including through the 2008 Great Recession. To do this, the Board has periodically cut costs while focusing on Temple's mission; annually increased dues marginally to keep up with rising costs; and welcomed donations to support Jewish education, scholarships and other important Temple activities.

#### Do dues and fees cover Temple Israel expenses?

No. Dues and fees cover 80% of Temple's annual operating budget. Temple Israel endowment funds, outright donations from congregants, support through the Voices of Inspiration Benefit, and grants are other important revenue sources in our budget.



#### ◆ Don't program fees cover program costs?

Not always. The fees charged for our Religious and Hebrew schools, for example, reflect market rates but cover only a portion of the cost of the education program. Temple Israel endowment funds, Temple operating funds and an annual grant from the Minneapolis Jewish Federation cover the difference. The Adult Education program, which offers Hebrew training and respected scholars, is subsidized and still many request scholarships to participate. Our New Horizons program, for people over 70, keeps fees low for people on a fixed income while providing a delicious, healthy dinner with entertainment and camaraderie.

Annual Operating Budget \$5,217,509

#### **→** Is each generation paying its fair share?

It is a myth that younger families are not paying their fair share. A full-paying family with two children in Religious School is spending \$3,840 on Jewish education each year, in addition to their annual financial commitment (dues), Camp TEKO and youth program fees. Young families are asked to stretch financially at a time when they are building their livelihoods, and they are responding by saying "yes." Even with subsidized school fees, 16% of students still require scholarships. Temple Israel will never turn a child away from a Jewish education for lack of ability to pay. Older generations at Temple have always stepped in to help the young.


#### **→** What is magic about \$2,500?

If every family household paid \$2,500 each year, Temple Israel would be able to provide all the services, lifecycle events, programs, classes and community engagement that our congregation expects and requests. However, not all Temple families are aware that the cost of keeping Temple viable has surpassed what they pay in dues and fees, and not every family can afford to pay this amount.

#### ◆ Why does Temple have deferred maintenance needs?

Over the years, the Board has had to make hard choices. Important maintenance has been deferred in order to balance the operating budget, while still maintaining a safe and healthy environment. Temple is currently at a crossroads. The capital campaign under consideration would address many of these

issues while planning for improved and renewed 21st century facilities.

#### ◆ Why should I pay \$2,500 if I go to Temple only a few times a year? Let someone else pay.

Temple Israel is here for you 24 hours a day, 365 days a year. If you become ill or a loved one dies, the clergy are here for you. At joyous times in life - anniversaries, weddings, baby namings and B'nai Mitzvah, the community is here for you. If you believe in a vibrant Jewish future, Temple is educating and creating young Jews daily to make sure that your vision is realized. If anti-Semitic rhetoric is voiced in Minneapolis, Temple stands strong as a voice for Jewish values in the city. An investment in Temple is an investment in your community, your family and yourself, and helps assure the Temple community is here for all its members when they need it.

## **Planning Study Update**

## **Campaign Feasibility and Planning Study**

### **Over 900 Families Provide Input**

At Rosh HaShanah we asked for your input into the possibility of a future fundraising effort to renovate and upgrade our Emerson campus, make improvements to Camp TEKO, maintain the Temple Israel Memorial Park and strengthen our endowment. And once again you responded with thoughtfulness and insight.

Almost half of the households in our congregation gave input through written and electronic surveys, as well as in face-to-face interviews. Thank you!

Temple's strategic plan identified many areas of need; the master facilities plan provided a physical road map; and the campaign feasibility and planning study prepares Temple Israel to take action. Here's what we learned:

Temple Israel meets or exceeds national campaign planning benchmarks in critical areas:

- 97% of face to face interviewees had a "positive" or "very positive" perception of Temple Israel, as did 89% of all survey respondents.
- Half of interviewees indicated willingness to serve on a campaign committee or take an active leadership role.

- 83% believed that Temple Israel should move forward with a campaign.
- 96% indicated they would make a gift to a campaign.

You mentioned most often the need for an updated education wing and the need to address maintenance and repairs, such as ongoing issues in the outdated kitchen, damage under the Emerson Avenue stairs, and the deteriorating heating and air conditioning systems.

Temple Israel leadership is now determining steps to convert the study's recommendations into an action plan. This will unfold over the next few months and years. Our Temple and Foundation Boards are still in the planning stages and are studying options to phase capital priorities and determine where resources should be allocated.

This is an exciting time for Temple Israel, as we will have the opportunity to support and witness the fulfillment of major needs identified in Temple's strategic plan. ## Two Women; One Temple Story



A few weeks ago a woman I had never met walked into my office at Temple and told this story, which I want to share with you.

Her mother and father were married at Temple

many decades ago. She herself went to another synagogue as a young parent, but later in life, found herself back at Temple – her spiritual home. By then she was dealing with a chronic medical condition, and she struggled financially. Temple became her sanctuary of support, and Temple scholarships underwrote her own daughter's Jewish summer camp experiences.

Over the years, her medical issues persisted and finances remained tight. Eventually she stopped coming to Temple.

But a few months ago, to her amazement, she inherited a sizeable gift from a Temple friend. The gift had been

written into her friend's will. Shocked and grateful, she returned to Temple for the first time in years in order to say "thank you."

"Years ago I received the gift of a supportive Jewish community from Temple. This year, I received a gift of money from a generous Temple friend," she said. "Temple kept me on as a congregant when I had nothing, and I always said that if I ever had any money, I would give back."

She directed a portion of her inheritance to an endowment fund at Temple that is named after her friend.

Her friend, generous in so many ways, not only supported others through her will, she also designated a gift for Temple.

Together, the generosity of these two women - one through her will, and the other through her inheritance – will benefit many families in the vears ahead.

### The Time Is Now

### Tax-free giving from your **IRA** expires December 31

If you have been considering a seat plaque in the sanctuary to honor your family, a Temple fund in your name or that of a loved one, a donation for scholarships to TEKO or for students in our school, a brick or bench in the Star of David Recognition Garden at Memorial Park, or simply a direct gift to Temple or the endowment, now is the time.

For congregants age 70½ or older, the IRA charitable rollover allows you to transfer a maximum of \$100,000 this calendar year from your IRA to one or more qualifying charities without undesirable tax consequences. This option expires Dec. 31, 2013.

To contribute in this way, you must:

- Be 70½ or older.
- Transfer no more than \$100,000 in total in the 2013 calendar year.
- Have your IRA custodian transfer the funds directly from your IRA to Temple Israel, the Temple Israel Foundation and/or other qualified charities.
- Make your gift by December 31, 2013.

Another powerful option is to launch your legacy gift for Temple Israel using a qualified charitable distribution. Those planning a legacy gift – a gift in your will or estate plan - can set up an endowment fund now with \$10,000 or more. You will have the joy of watching your philanthropy take shape during your lifetime. Upon your death, funds designated for Temple in your estate will be added to your endowment fund to further strengthen and sustain your gift.


